Operational Permit Fees

Hot work operation	\$100 per use
Liquid or gas-fueled vehicles or equipment in assembly buildings	\$100 annually
Mobile food preparation vehicles [Food Trucks]	\$100 annually
Open flames and candles	\$100 per use

Inspections and Testing Fees (no application fee)

After-hours (when staffing allows)	Actual overtime cost of an employee(s) and 2-hour minimum
Re-inspection	\$250
Contractor no-show for scheduled inspection (15-minute leeway)	\$250
Fail to cancel inspection within 24 hours	\$100
State Licensed Facilities (Licensed Nursing Homes, Licensed Assisted Living or Board and Care Facilities, School/Educational Facilities, Head Start Programs, Daycare Facilities, Licensed Foster Homes with seven or more children)	\$100 and consists of a yearly inspection and annual permit. Re-inspection fees shall apply.
